

SMALL ESTATE GUIDELINES

- ❖ MUST BE 45 DAYS FROM THE DATE OF DEATH
- ❖ ORIGINAL OR COPY OF DEATH CERTIFICATE TO PROVE DATE OF DEATH
- ❖ ASSETS **CANNOT** EXCEED \$100,000.
- ❖ HAS TO BE NOTARIZED – THIS CAN BE DONE IN OFFICE BY A DEPUTY CLERK FOR AN ADDITIONAL \$5.00
- ❖ \$28.00 IN **CASH (NO CHECKS OR DEBIT/CREDIT CARDS ACCEPTED)** THIS WILL INCLUDE (1) ONE CERTIFIED COPY
- ❖ ANY ADDITION COPIES IS A \$5.00 CHARGE
- ❖ IF YOU HAVE TO AMEND YOUR SMALL ESTATE THERE IS A \$10.00 FEE

Note: To be used only when valuation of estate less encumbrance and excluding the homestead of and summary allowance for widow and minor children does not exceed \$100,000 and where there has been no personal representative appointed. Section 28-1-101 Revised August 12, 2005.
